

## THE CORPORATION OF DELTA

### BYLAW NO. 7655

*A Bylaw to close certain portions of a public highway  
and cancel the dedication of such highway*

---

WHEREAS pursuant to Section 40 of the *Community Charter*, S.B.C. 2003, c. 26 as amended, the Council may, by Bylaw, close all or part of a highway that is vested in the municipality to some or all types of traffic and may cancel the dedication of a highway that has been or is being closed;

NOW THEREFORE the Council of The Corporation of Delta, in open meeting assembled, ENACTS AS FOLLOWS:

1. This Bylaw may be cited for all purposes as **“Delta Road Closure and Cancellation (Tsawwassen Golf & Country Club Ltd. – LU007923) Bylaw No. 7655, 2017”**.
2. That portion of public highway outlined in bold and marked “Road to be Closed” on the Reference Plan prepared by Watson and Barnard B.C. Land Surveyors, based on a field survey completed on January 5<sup>th</sup>, 2016, a reduced copy of which is attached hereto as Schedule “A” (the “Closed Road”), is hereby stopped up and closed to all traffic.
3. The dedication of the Closed Road is hereby cancelled and removed.
4. The Closed Road shall cease forever to be a public highway and title thereto shall be vested in The Corporation of Delta.
5. Schedule “A” attached hereto shall form part of this bylaw.

6. The Mayor and the Municipal Clerk of The Corporation of Delta are hereby authorized to execute such conveyances, deed, maps, plans, receipts and documents on behalf of The Corporation of Delta as may be necessary for the purposes aforesaid and to affix the Corporate Seal of The Corporation of Delta thereto if necessary.

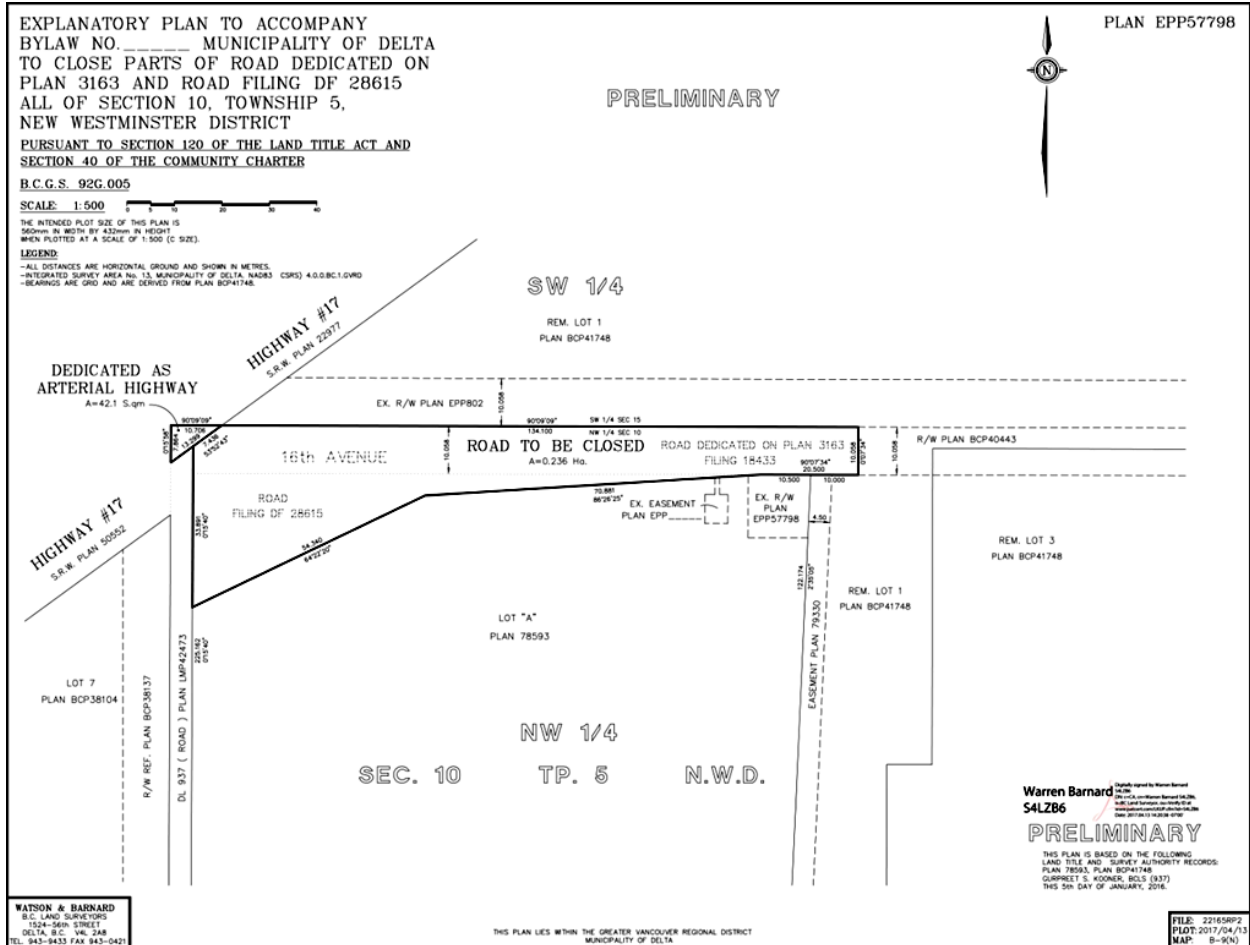
